Dear Gym Owners, Coaches and Gymnasts,

The 2011 Texas Judges Cup is fast approaching. Mark your calendar for Sept 30-Oct 2, 2011 and choose your meet site. The Judges Cup will host competition for Levels 2, 3, 4A, 4P, 5A, 5P, 6A & 6P. Once again, we have meet sites around the great state of Texas. We will be hosting competitions in the Houston area (Spring) at WGA, in the Dallas area at FEW in Euless, in West Texas at Permian High School in Odessa-hosted by Permian Elite, and in San Antonio at Alamo Gymnastics.

We will offer small and large team competition for levels 2-6. Team awards (50% recognition) will be presented at the conclusion of the last session of competition for each level respectively (one set of awards per level). In addition to the regular team awards, there will be a Texas Judges Cup Team Competition. Designate any 6 of your athletes (any age, Levels 4-6 only) to compose your Judges Cup Team. This is an additional team competition and requires a separate team entry fee. Designation may change up until competition session begins for individual athletes. (cannot change designation after a gymnast starts competition). The Texas Judges Cup Team Award will be presented after the conclusion of the final session of the weekend. (50% recognition). To designate your team, just check the JC Team box on the entry form next to the athlete's name. Remember, this is a separate team competition and requires an additional team entry fee. (Individual clubs are responsible for making arrangements to collect their awards.)

Again this year, the Texas Judges' Cup will have 100% medal recognition for all events, for all levels (2-6). We are also planning on giving each athlete a medal bag as a special gift.

Please note that in order to avoid a late fee, I must **receive** your entry form and payment by **Friday, September 9, 2011**. Please be aware that the large number of CUSTOM medals we will be ordering require longer production time. FAXed entries will not be accepted and will not hold your "spot" at a particular meet site.

Please number the meet site you wish to attend in numerical preference (1-4) at the top of the entry form. Be sure to indicate a Judges Cup Team if desired. Mail to Carol Robuck with a single check made payable to NAWGJ. See address below.

Please note that the entry fee is \$60 for ALL levels.

All Team competitions, small, large, or Judges Cup Team are \$40.

ENTRIES MUST BE RECEIVED BY Friday, September 9, 2011 TO AVOID LATE FEE!!
DO NOT FAX your entry. Entries are not official unless completed entry form is received with payment along with confirmed athlete numbers.

Your preferred meet site may fill early. Please get your completed entry in early.

We are looking forward to seeing you this year and hope that you will have a great time and find the competition exciting.
